- --Dan Cosgrove Shelter applied for a \$`10,000 Loeb grant for a dog training program and received \$4500.
- --- Laura Burban, our DCAS Executive Director received an award on November 16th from the Mark Twain House at their annual Bark Twain Bash for her outstanding service and help to the City of Hartford Animal Shelter.
- --Grethen Dale reported that the Dan Cosgrove Medical and Wellness Endowment was up and running. 150 letters have been sent out to major supporters and donors of the shelter. Several major press releases have been published and WTNH did a TV spot on the HOME fundraiser and the Dan Cosgrove Medical and Wellness Endowment.
