Reports:

Superintendent Brian Devlin reviewed the Wastewater Treatment numbers: In February 2025, sewage processed 3.6 avg mgd, septic waste processed 727,011 gallons, and septic receiving revenues were \$48,709.73

Plant Operations:

Serviced RAS Pumps, Main Blowers, reaeration blowers. Clean septic receiving unit weekly. Clean D O probes located in the oxidation ditches. The plant process is running in the range of permits.

Collection system:

Clean and inspected pump stations weekly; pumped out holding tanks weekly. Painting the interior of 139 Pump Station. Removed a tree at Tideland's Pump station. Replaced low water float and replaced check valve at Bradley Pump Station. Repaired generator at Sybil Pump Station. Replaced generator battery at Central Pump Station. Clean Pumps and check valves at Hemlock Pump Station. Jetted 6877 feet of sewer line and camera 1389 feet of sewer line.
