REGULAR SCHEDULED MEETING MINUTES

March 5, 2025 7:00 PM, Community House, 46 Church Street

The Ways & Means Committee held its regularly scheduled session on March 5th, 2025 at the Community House. Also in attendance were First Selectman Jamie Cosgrove, RTM members Tracy Everson, Frank Twohill, Ray Ingraham, and Adrian Bonenberger, as well as Finance Director Jim Finch.

Resolved: that the RTM consider and if appropriate increase appropriations for the Fiscal Year 2025 General Fund Budget from \$135,311,096 to \$135,792,612. This increase will be funded through an appropriation from fund balance and will be used to supplement the contingency account to cover retroactive wages.

At the request of Chairman Hartwell prior to discussing this specific agenda item, Finance Director Finch reviewed with the committee a one page summary of fund balance movements taken recently by the Board of Finance that would be addressed during the meeting (see "Finance Director Finch fund balance overview.pdf"). It showed that the undesignated fund stood at \$53.7M in June 2024, which would be reduced by \$9.1M through BOF appropriations if approved by the RTM, further restricted by \$6.1M in BOF "assignments" (promises of future appropriations if needed), and added to by \$8.5M coming from the Medical Self Insurance Fund. The net result is that the undesignated fund would have \$46.9M available.

Agenda item #3 was then discussed and approved.
