Prospective bidders, and all those concerned, are hereby informed that the following is made a part of the bid documents, which should be amended as follows:

The following questions were received about the RFP, with the answers following:

1. Can clarity be provided on what traffic control will be required?

There is a small portion of the project within the State's right-of-way in which the State may require a police detail or certified flagger. Once the State Encroachment permit is obtained it will state what will be required. The Town does not have a requirement for police detail or certified flaggers within the Town's right-of-way. The traffic control to be used for the duration of the project will be left to the Contractor's judgement and shall follow the scope of work language in the bid documents. The contractor has the option to hire a police detail or certified flagger, but this will be considered incidental to the project and not paid out separately.

2. Are we to have both a CTDOT Bond and a Bond with the Town of Branford?

Yes, a bond will be submitted to both the Town and State. See Section 1 – General Terms and Conditions and CTDOT Pre-Approval Letter for additional information.

3. Who supplies the CTDOT with stamped signed engineered drawings – Town or Contractor?

The Town has a stamped and signed set of engineering drawings that will be give the awarded Contractor to submit along with the encroachment permit to CTDOT.

4. Testing, who incurs the cost and how often is it required?

See Supplemental Instructions to Bidders – Section 14. Materials Testing, Sampling, Certifications and page 48 of the bid documents for testing schedule.

5. Will the Town require compaction testing for installing a new Process Base and the testing of the installed concrete?

The Town holds the right to conduct compaction testing at any time during construction at the Owner's expense. See page 48 of the bid documents for Minimum Schedule of Acceptance Testing.

6. Will the Town consider having a police allowance for this project?

No, police detail or certified flagger may only be required on the small section of the project within the State's right-of-way. The Town does not have a requirement for police detail or certified flaggers within the Town's right-of-way. See bid documents "Scope of Work" for additional information.

7. Will the Town consider a line item for a certified flagger?

No, police detail or certified flagger may only be required on the small section of the project within the State's right-of-way. The Town does not have a requirement for police detail or certified flaggers within the Town's right-of-way. See bid documents "Scope of Work" for additional information.

8. The concrete thickness on the drawings is 8" – is this for all placement of new concrete?

No, the 8" Thick Concrete shall end where labeled "End of Installation of Concrete Sidewalk – 8" Thick" on the drawings. The remaining sidewalk shall be 5" thick per the standard details.

9. Will the Town of Branford be requiring submittals for this project?

Yes, submittals shall be required for stone curbing, concrete pavers and all furniture. Refer to section 2 of the Introduction to the Special Provisions for additional information.

10. Crosswalks – Epoxy paint only?

Yes, all striping shall be epoxy.

11. Does the Town require wire mesh in the new concrete and a concrete sealant applied to finish?

The Town will only require wire mesh in the new concrete per the standard details.

12. Does the Town have any CAD files for surveying purposes?

Yes, a CAD file for the alternative bid can be provided. The base bid does not require staking.

The proposal sheet has been updated to remove the pollinator garden line item as it is not being proposed. Attached revised proposal sheet shall be submitted with bid submission.
